Deposit: Deposit to hold a puppy (not yet born or already born) in your name is \$200. This amount is non refundable unless the follow arises:

- a) dam does not produce a litter of puppies and buyer does not want to wait for the next available litter
- b) sex of puppy reserved is not born in the litter and buyer does not want to wait for the next available litter
- c) health of the reserved puppy is not acceptable to the buyer before delivery when reported following health check by Heartland Classics, LLC's veterinarian.

Under these circumstances, full refund of the \$200 deposit will be refunded within ten days following the announcement to buyer.

No deposit will be refunded due to a change in heart, medical issues, moving homes, a new baby on the way, divorce/marriage etc. You can always postpone the arrival of your new puppy and ask that we retain your deposit for a later adoption.

Shipping information: Puppies can leave for forever homes at ten weeks of age. Please do not ask for earlier departure. We comply by rules set forth by the state of Nebraska and the rules governing the airlines. Shipping is a service, not a condition of sale. Normal shipping days are Thursdays, although at times we may be able to accommodate other dates. We ask that you make yourself available to accept your new baby on Thursday of your week of choice.

The buyer understands that if an airline cancels/delays a flight it is an inconvenience to both the buyer and seller and efforts will be made to make the next available flight within our means.

A \$50 shipping preparation charge is added to the total cost. This is reimbursement for the new kennel that your puppy will arrive in (appropriate for the size of your puppy at this time), detachable food dish, veterinarian paperwork as required by the airline for flight clearance, and all other enclosed documents and pamphlets.

Picking up: Your new puppy will be ready to leave for a forever home at ten weeks of age. Of course a shipping preparation charge is not added as a kennel is not required for departure. We do not offer delivery of puppies due to our commitment to our puppies and our family.

Microchip: Your new puppy has been microchipped. Not only is it essential that this puppy be identified as the puppy that you have chosen to purchase, but this is our veterinarian's way of tracking all important health information. It is our way of keeping records concerning your puppy for registration purposes as well. We will register the microchip for the buyer using the information at the top of this form. Buyer will be charged a \$20 microchip registration fee (this is the same amount as you would be charged if you would complete this process yourself).

Registration: You will be presented with copies of the parental registrations for your viewing upon receipt of the puppy if so requested. All puppies are sold on a spay/neuter contract. Any available registrations (such as ACA, APR, UKC, etc) are sent along with the puppy if we have received them back from the registry before departure, but you will have the LIMITED box checked on any such form. This means that offspring of this puppy are not eligible for registration. Should a reason arise at any time that an animal cannot be registered with a particular breed club, a replacement registry will be issued with an alternative breed registry if available - as most of our dogs are registered with multiple registries.

Purchase of an animal as a "Pet" is to be for use as a pet only, and not for breeding, showing or any other use. If determined that the animal purchased as a "pet" has or is being used for any purpose other than as a pet, Purchaser specifically agrees that he or she shall owe a remaining balance to Seller for the full price of a "Breed/Show" dog.

Vet Inspection: Your puppy has been vaccinated, dewormed, and vet inspected. You will be presented with copies of the inspection performed by our veterinarian. (inspected are eyes, ears, bite/teeth, nose, skin, joints, feet, heart, lungs, abdomen and a check for external parasites). Health inspection form can be requested before flight if you provide a fax number or will automatically be included in your paperwork when your puppy is shipped to you or when you pick up on site. You will also receive two copies of all vaccinations and dewormings done (including brand names, lot numbers and exp dates) so that you may present one to your new veterinarian and keep one for yourself.

We are anxious to have your vet meet your new puppy, you will need to have this done within 48 hours for our guarantee to be valid. If your veterinarian reports the puppy to be healthy, the buyer agrees to retain possession and thereafter hold the seller blameless and not liable for further medical condition of the puppy/dog.

Not covered by seller are common puppy ailments such as parasites, hernias, undescended testicles, under or overbites, allergies, ear mites, coccidia, giardia, hypoglycemia and respiratory infection. Parvo and distemper are not covered after 48 hours from departure time from seller's residence.

Speculation never is considered as a diagnosis. Should the veterinarian (Doctor of Veterinary Medicine) find the puppy to be suffering with a covered genetic condition or illness that occurred while in the seller's care, buyer agrees to immediately return the puppy to the seller at the buyer's expense. Within ten days, we will issue a refund check in the amount of the purchase price of the puppy. Flight expense, microchip registration fees, shipping preparation fees, veterinarian fees, etc will not be included in this refund. Only the amount of purchase for the puppy (the amount listed on the top of this contract) will be refunded. **DO NOT TREAT THIS PUPPY MEDICALLY AS YOU WOULD BE PLANNING ON RETURNING THIS PUPPY TO US!**

The buyer agrees to provide the seller with written documentation supporting the claim. This would be documentation from the attending veterinarian including diagnosis, specific tests run and results of those and suggesting the return of the puppy to the breeder. (Previously mentioned "not covered" items are not grounds for return.) Also included should be this original signed guarantee and all paperwork (including registrations). All can be sent to us at the address at the top of this guarantee.

Should you choose to retain the puppy and treat any medical illness found, buyer agrees not to hold seller financially liable for any veterinarian expenses. Treatment can be expensive depending upon region of the country and seller will not be accountable for veterinarian fees, time lost from work, hardship to the family, loss of sleep, etc.

In the event of a pet's death within the first seven days, the buyer agrees to have an autopsy completed. If the autopsy results state specifically that death resulted in a genetic illness or an illness which was contracted while in the seller's care, the price of the puppy and the autopsy fee will be refunded. Within ten days of receipt of invoice, we will issue a refund check in the amount of the purchase price of the puppy and autopsy fee. Recall that flight expense, microchip registration fees, shipping preparation fees, veterinarian fees, etc will not be included in this refund. Only the amount of purchase for the puppy (the amount listed on the top of this contract) will be refunded.

One Year Guarantee:

Your newly purchased puppy comes with a one year guarantee!

The buyer is responsible for all daily healthcare and maintenance of the pet, including all immunizations and examinations recommended after purchase, as well as providing necessary medication and follow-up treatment from all veterinarian visits. The buyer is responsible for any and all expenses accumulated from this day forward. Seller is not responsible for any airborne viruses or other illnesses contracted after the dog has been exposed to a new environment (i.e. influenza, parvo, pneumonia, etc.).

If this puppy develops any genetic disorder before the age of 12 months (heart, lungs, liver, cancer, hip/elbow dysplasia, eyes)the buyer provide the seller with a letter from the attending veterinarian (DVM) on office letterhead which includes documentation of diagnosis, diagnostic test results, breed of dog, birthdate, microchip number and a signature of verification. This genetic disorder must be verified by a licensed veterinarian and documentation presented on/before the puppy's first birthday.

Once the puppy has undergone surgery or corrective measures within the following 60 days, submit a copy of the bill. Reimbursement will be paid up to, but not to exceed the actual cost of the puppy (listed on the front page of this document) to the buyer minus the cost of food, over the counter medications and diagnostics within 30 days of receipt of ALL required documentation.

Heartland Classics, LLC does not guarantee size, color, trainability, temperament of the dog and all other things controlled by Mother Nature herself.

If at anytime in your puppy's life you decide that you just do not want or cannot care for your puppy/dog any longer we ask that you return your dog to us if feasible. We can help in rehoming when necessary. No monetary compensation will be given in rehoming situations.

If for any reason any litigations of this transaction occur, they shall be held in either Omaha or Lincoln, Nebraska. Seller is entitled to attorney fees and court costs from any litigation involved concerning this agreement and/or the afore mentioned puppy. This warranty complies with Nebraska State Laws.

This guarantee is non-transferable should seller chose to rehome this puppy.

In the event that Heartland Classics, LLC discontinues business, is sold, or eliminates the breed, this guarantee is null and/or void.
